

## Proposed Constitution Changes – River East Minor Hockey Association

Annual General Meeting May 28, 2017

### By Law No.9

Current: All players must register with the Association to play on Association or Community Centre teams. Following selection of Association teams the players will be returned following evaluations to the Community Centres or amalgamations thereof for placement. The Association will make every effort to deal with any situations where there is an abundance or shortage of players in an age group.

Proposed: All players must register with the Association to play on Association or Community Centre teams. The Association will make every effort to deal with any situations where there is an abundance or shortage of players in an age group.

Rational: Housekeeping to reflect the team formation rules now in place. House League only remains under the Community Centre banner with the rebranding to the Royals for all A hockey.

### By Law No.12 c) 2. Duties of the Vice President “A” Direct Entry

Current: Coordination of A1 tryouts for the R.E. Royals for 11 & up.

Proposed: Coordination of Royals A tryouts 11 and over.

Rational: Housekeeping. The position is responsible for all A teams in the category, not just A1.

### By Law No.12 c) 3.

Current: Registration of River East hockey A1 teams and submission of documentation to the River East Registration Director.

Proposed: Coordinate team registration of A teams 11 & over with the River East Registration Director.

Rational: Housekeeping. The Registrar in fact is the individual with access to the HCR for the registration of teams, and the VP A Direct Entry is responsible for all A teams in the category, not just A1.

### By Law No.12 c) 4.

Current: Approval of fund raising for the River East A1 teams.

Proposed: Approval of fund raising for A teams 11 & over.

Rational: Housekeeping. All teams A1/2/3 in the category fall to this individual.

By Law No. 13 b) 2. Duties of the Vice President "A" East League

Current: Coordination of A1 tryouts for 8A1 to 10.

Proposed: Coordination of Royals A tryouts for 10 & Under.

Rational: Housekeeping. The position is responsible for all A teams in the category, not just A1.

By Law No.13 b) 3.

Current: Registration of River East A1 teams and submission of documents to the River East Registration Director.

Proposed: Coordinate team registration of A teams 10 and under with the River East Registration Director.

Rational: Housekeeping. The Registrar in fact is the individual with access to the HCR for team registration, and the VP A East League is responsible for all A teams in the category, not just A1.

By Law No.13 b) 4.

Current: Approval of fund raising for the River East 8A1 to 10A1 team.

Proposed: Approval of fund raising for Royals A teams in the 10 & under category.

Rational: Housekeeping – VP responsible for all A teams in the category.

By Law No.14 b) 2. Duties of the Vice President AA Hockey

Current: Organize the registration of players for AA tryouts.

Proposed: delete and renumber the section

Rational: Housekeeping. Registration for AA Hockey is part & parcel of the on line registration.

By Law No. 14 b) 4.

Current: Registration of River East hockey AA teams and submission of documentation to the River East Registration Director.

Proposed: Coordinate team registration of AA Marauder teams with the River East Registration Director.

Rational: Housekeeping. The Registrar completes the team registration process on the HCR.

By Law No.16 a) 4. Duties of the Vice President “Female” Hockey

Current: Registration of REMHA female elite and community centre teams and submission of documentation to the River East Registration Director.

Proposed: Coordinate registration of North East AA and A teams together with the Lord Selkirk female hockey representative and the River East Registration Director.

Rational: Housekeeping. The Registrars of REMHA & LSMHA register the teams hosted by their respective areas.

By Law No.21 b) Duties of the Ice Schedule Director

Current: Will coordinate ice scheduling in conjunction with Parks and Recreation.

Proposed: Will coordinate ice scheduling in conjunction with all arena venues available to the Association.

Rational: Housekeeping. Parks and Recreation provide only a limited portion of the ice requirements of the Association.

By Law No.23 a) Duties of the Equipment Director

Current: Will be responsible for sizing, purchasing sweaters for the A1 program as well as maintaining try-out jerseys for the AA program.

Proposed: Will coordinate sizing and purchase sweaters for the Royals program as well as maintaining try-out jerseys for the Association A and AA teams.

Rational: Housekeeping. Reflects the rebranding of A1/2/3 to “Royals”.

By Law No.26 a)

Current: The Second Vice Presidents Committee in conjunction with the Coaches Selection Committee will continue throughout the year to act as arbitrators between coaches, players and parents.

Proposed: The AA Vice Presidents Committee in conjunction with the Coaches Selection Committee will continue throughout the year to act as arbitrators between coaches, players and parents.

Rational: Housekeeping. Designation of AA VP changed several years past.
